Roles & Responsibilities

ACTION PLAN

a) Safety and Security

Though the institution being co-education one, gender related issues are very minimal. Every measure is taken by institution to provide safety and security on the campus. Even then, in anticipation of any such gender related issues the college has constituted various committees such as, Anti-raging cell, Grievance and redressal cell and Women empowerment cell. b) Counselling

The class teachers themselves act as counsellors who interact the students on regular basis and counsel both boys and girls on gender equality. Every year an awareness programme on health and hygiene is organised by inviting local government women doctors exclusively for girls' students

c) Common Room

The college has established a common room known girls' waiting room with required facilities.

A grand event to celebrate women's achievements, with debates, skits, and awards recognizing women change-makers.
